BRIEFING NOTE

Review of Pakistan's GSP+ Status - The Human Rights Violations

Prepared for: The European Union By: World Sindhi Congress (June 2025)

Purpose of the Dossier

The World Sindhi Congress submits this document to the EU as part of the review of Pakistan's GSP+ status. The dossier presents extensive evidence of Pakistan's failure to uphold the 27 international conventions tied to its GSP+ trade privileges—focusing on grave violations in Sindh affecting environmental justice, land rights, civil liberties, and minority protections.

Key Areas of Violation

1. Environmental Destruction

- Water Misappropriation: Six mega-canals, sanctioned under the "Green Pakistan Initiative," divert Indus River water away from Sindh, breaching the 1991 Water Accord. This has triggered:
 - Crop failures, seawater intrusion, and drinking water crises.
 - Ecological collapse of the Indus Delta (shrunk by 92%).
 - Poverty, displacement of communities.
- Karoonjhar Mountains Mining: Illegal granite extraction continues despite court bans, causing:
 - Biodiversity loss, water contamination, destruction of historical religious sites, health hazards, loss of livelihood and destruction of communities.
 - Violations of the Convention on Biological Diversity, UNFCCC, and ICESCR.

2. Military Land Grabs

Coastal Karachi Displacements: Army-led DHA attempted to seize 5,000–6,000 acres, risking displacement of 45 fishing villages.

- Corporate Farming Takeovers: Over 52,000 acres handed to militarycontrolled Green Corporate Initiative; 2 million more acres targeted.
- Haleji Lake Encroachment: Ramsar-protected wetland under threat from development projects.
- These actions breach ICCPR, ILO, and Ramsar Conventions, and show disregard for Indigenous consent (UNDRIP).

3. Human Rights Violations

Enforced Disappearances & Killings

- At least 500 Sindhi activists abducted since 2019: 55+ still missing.
- High-profile cases include the murder of activist Hidayat Lohar, despite his earlier disappearance and release.
- Government agencies, including intelligence services, are implicated, with no accountability under the Commission of Inquiry on Enforced Disappearances.
- The amended disappearance bill (2021) discourages complaints and promotes impunity.
- These abuses violate ICCPR, CAT, and the UN Declaration on Enforced Disappearance.

Religious Minority Persecution

- Around 1,000 forced conversions annually; ~300 involve Sindhi Hindu girls.
- Minor victims like Priya Kumari (age 7, still missing) symbolize state failure.
- Widespread misuse of blasphemy laws leads to violence and judicial complicity.
- Pakistan has failed to enact protections despite efforts in Sindh's legislature.
- Breaches include CRC, CEDAW, ICCPR Article 18 (religious freedom).

4. Collapse of Justice and Governance

- **Fatima Phuriro (age 9)**: Tortured and raped while working as a domestic servant; accused elite using influence to evade justice.
- **Nazim Jokhio (activist)**: Murdered after exposing illegal hunting; politically connected suspects acquitted via out-of-court settlement.
- Nasrullah Gadani (journalist): Assassinated; implicated lawmaker remains free.
- **Dr. Shahnawaz Kumbhar**: Killed in police custody after false blasphemy charge.
- All illustrate political immunity and breakdown of due process, violating ICCPR Articles 6 & 14 and UNCAC.

5. Suppression of Freedom of Expression & Assembly

- Peaceful protests (e.g., Voice for Missing Persons of Sindh) are met with arrests and harassment.
- Journalists reporting on state violence are silenced or murdered.
- Digital censorship of Sindhi voices is increasing.
- Violations of ICCPR Articles 19 (expression) and 21 (assembly) are routine.

WSC Recommendations to the EU

- Suspend GSP+ Privileges until Pakistan complies with its international obligations.
- 2. Deploy an Independent Fact-Finding Mission to Sindh.
- 3. Hold EU Parliamentary Hearings on Pakistan's human rights abuses.
- 4. **Support UN Investigations** and potential international legal action if Pakistan continues impunity for crimes like enforced disappearances.

Conclusion

The WSC urges the EU to uphold its values by acting decisively. Continued GSP+ benefits to Pakistan amid systemic abuses only fuel repression. A firm EU stance could incentivize reforms and offer relief to millions of marginalized Sindhi people.
